It seems that everywhere I go people remember a time when everyone kept honey bees, and that time was not long ago. Keeping bees just a few years ago did not require the hard chemicals and labor-intensive management techniques require to maintain today's colonies. Expensive equipment, high colony mortality rates and low prices for honey forced many beekeepers, both commercial and hobbyists, to just give up.

Remaining beekeepers are a tough and resilient crowd. Survival depended on education, ingenuity, and guts. New honey bee predators and diseases seemed to appear on a daily basis. Chemical companies dipped into their bag of tricks, but seemed to cause additional

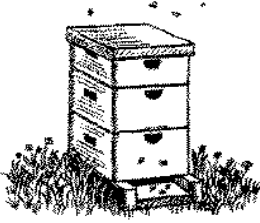

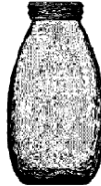

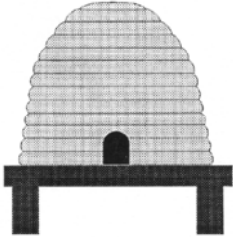

### Liquid Mineral Oil Treatment for Varroa

For those of you who missed the spring state meeting this year at Bob Harvey's farm in south Jersey, I'd like to pass on the most recent method of treating colonies for varroa mites using liquid mineral oil (as opposed to fogging).

The Harveys have switched their operation entirely to mineral oil treatments, used in conjunction with their own hygienic queen breeding program and open screen bottom boards. They no longer use any hard chemicals such as fluvalinate (Apistan) or coumaphos (Check-Mite) at all. One added advantage to the mineral oil for the Harveys is that it also kills small hive beetle, which many of you may know the Harveys have in their operation because of their migratory operation between here and Florida, where the beetles are rampant.

I first heard of this method at EAS several years back, where Master Beekeeper Billy Davis of

Virginia shared his use of mineral oil with me and Cathie Skove over lunch between workshops. He claimed to control varroa exclusively with liquid mineral oil and open screen bottom boards. Obviously I was intrigued, but did not follow up on this lead because I could find nothing on it in the major beekeeping publications. The idea is that the bees walk in the oil and, in grooming, manage to get enough of it on themselves to somehow induce the mites to let go. They fall through the open screen and are gone. It does not kill mites in sealed brood so several applications are needed to treat the entire 21-day brood cycle.

The basic method is as follows: In your broodnest, run a

bead of mineral oil using something like a honey bear with a spout along the top of frames 3 and 7, and beads of oil along both lines of frame rests (rabbets), going right across the ends of all the frames as you do so.

Smoke the bees heavily before you do this to drive down the bees.

Mineral oil will kill bees if you get it on their bodies. That's it.

The Harveys run one hive body as their brood nest, and if you use two (or three mediums as I do), Mike Stanghellini recommends repeating the treatment in each brood super.

The mineral oil treatment should be repeated twice at one-week intervals - a total of three applications a week apart.

I am trying this method for the first time this year on my one and only colony with any substantial population of varroa, and one just under my threshold count. This seems to be a bad year for the mites and a good one for us

and the bees, at least in northern Jersey. The main reservations I have about the treatment center around the fact that the beekeepers I know who use it (Harvey and Davis) both winter their bees in southern states.

Will it be sufficiently effective to protect honey bees subjected to the greater stress of a northern winter?

This seems like a good year to find out because if it's not, I risk only one or two colonies, not my whole operation. Mike Stanghellini will be doing some research trials on this method this summer. We'll keep you posted on how he makes out. I will feel a great deal more comfortable when there is some hard scientific research to back up the empirical stuff.

Another question is whether the mineral oil works against tracheal mites. One would think that it might, possibly by the same mechanism as a grease patty.

If you are interested in trying this, I obtained the right grade of oil from STE Oil Co. in Texas. It's "Crystal Plus Oil: 70FG". This is a much lighter grade of oil than the stuff sold in drug stores as a laxative. STE's phone is 800-967-1931.

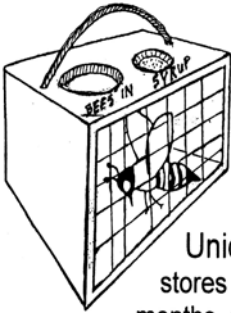
### **Sad news from Essex**

promise as a cheap and easy method of mite control and does not contaminate wax or honey. Genetic research on honey bees and mites is advancing our understanding of both insects and will continue to produce answers in the future. And the price of honey and bee products is up. Demand for specialty bee items is of particular interest and commands a good return on your time and materials.

Today's consumer has changed drastically in the last few years. Organic foods, with their higher prices, are in great demand, as are local crops. Farmers markets are springing up in town across New Jersey. Bee products such as soaps, lotions, candles, creams, and mead are sought after items, especially during the holiday season, but these items require proper labeling and packaging. 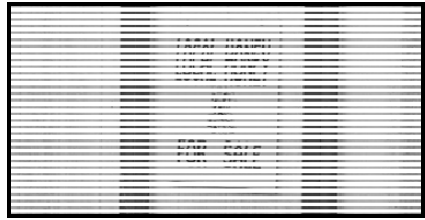
